HOUSE LOCAL BILL NO. 20-10

**A LOCAL BILL FOR AN ACT
FOR THE THIRD SENATORIAL DISTRICT**

To amend the Saipan Official Zoning Map Sheet 20 of 29, rezoning several lots from “Village Residential” to “Village Commercial” Zoning District.

**BE IT ENACTED BY THE THIRD SENATORIAL DISTRICT DELEGATION PURSUANT TO
CHAPTER 4, DIVISION 1, TITLE 1 OF THE COMMONWEALTH CODE:**

1 **SECTION 1. FINDINGS AND PURPOSE.**

2 The Saipan and Northern Islands Legislative Delegation find that it is appropriate to
3 rezone certain districts that the Commonwealth Zoning Board has recommended for rezoning
4 pursuant to Saipan and Northern Islands Legislative Delegation Resolution No. 16-2, D1,
5 entitled, *“To affirm the authority of the Saipan Zoning Board under the Commonwealth
6 Zoning Code to make determinations on zoning district boundary changes.”* The
7 Commonwealth Zoning Board has held a public hearing with respect to the district rezone
8 listed below and has transmitted its recommendations based on Zoning staffs evaluation and
9 the evidence presented at the hearing to the Delegation. The Delegation agrees that rezoning
10 these areas is in the best interests of the community.

1 **SECTION 2. AMENDMENT.**

2 This Act amends the Official Saipan Zoning Map, dated July 15, 2013 of the Saipan
3 Zoning Law of 2013. The amended sheet, listed below showing the rezoned district, is attached
4 hereto and replaces the prior version of this sheet as part of the appendix to the Saipan Zoning
5 Law of 2013:

6 ***Saipan Official Zoning Map Sheet 20 of 29***

7 *(Lots 001 H 06, 001 H 07, 001 H 08, 001 H 09, 001 H 10, 001 H 011, 001 H 012, 001 H 15,*
8 *001 H 16, and 001 H 17 from “Village Residential” to “Village Commercial” Zoning*
9 *District).*

10 **SECTION 3. SEVERABILITY.**

11 If any provision of this Act or the application of any such provision to any person or
12 circumstance should be held invalid by a court of competent jurisdiction, the remainder of this
13 Act or the application of its provisions to persons or circumstances other than those to which it
14 is held invalid shall not be affected thereby.

15 **SECTION 4. SAVINGS CLAUSE.**

16 This Act and any repealer contained herein shall not be construed as affecting any
17 existing right acquired under contract or acquired under statutes repealed or under any rule,
18 regulation or order adopted under the statutes. Repealers contained in this Act shall not affect
19 any proceeding instituted under or pursuant to prior law. The enactment of the Act shall not
20 have the effect of terminating, or in any way modifying, any liability, civil or criminal, which
21 shall already be in existence on the date this Act becomes effective.

1 **SECTION 5. EFFECTIVE DATE.**

2 This Act shall take effect upon its approval by the Governor or its becoming law
3 without such approval.


