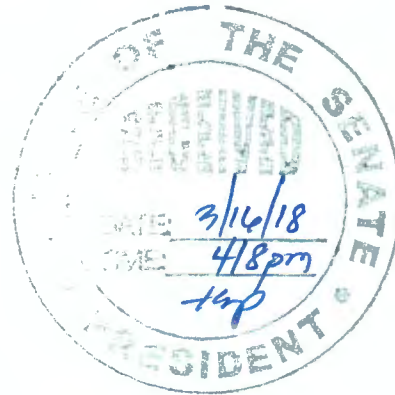

FOR THE THIRD SENATORIAL DISTRICT**

To re-appropriate Fourteen Thousand dollars (\$14,000.00) in B.U. 3389I, allotted under Saipan Local Law 17-04; Sixteen Thousand, Three Hundred and Eleven dollars (\$16,311.00) in B.U. 3374F, allotted under Saipan Local Law 17-09; Five Thousand, Two Hundred and Eighty-Seven dollars (\$5,287.00) in B.U. 3399H, allotted under Saipan Local Law 18-07; Ten Thousand, Two Hundred and Sixty-Two dollars (\$10,262.00) in B.U. 3400N, allotted under Saipan Local Law 18-24; One Thousand, Three Hundred and Thirty-Five dollars (\$1,335.00) in B.U. 3700H, allotted under Saipan Local Law 19-27; and Twenty-Eight Thousand, Seven Hundred and Sixty-Four dollars (\$28,764.00) in B.U. 3710D, allotted under Saipan Local Law 20-03; and for other purposes.

BE IT ENACTED BY THE THIRD SENATORIAL DISTRICT DELEGATION

PURSUANT TO CHAPTER 4, DIVISION 1, TITLE 1

OF THE COMMONWEALTH CODE:

1 SECTION 1. PURPOSE.

2 The purpose of this Act is to re-appropriate Fourteen Thousand dollars (\$14,000.00) in
3 B.U. 3389I, allotted under Saipan Local Law 17-04; Sixteen Thousand, Three Hundred and
4 Eleven dollars (\$16,311.00) in B.U. 3374F, allotted under Saipan Local Law 17-09; Five
5 Thousand, Two Hundred and Eighty-Seven dollars (\$5,287.00) in B.U. 3399H, allotted under
6 Saipan Local Law 18-07; Ten Thousand, Two Hundred and Sixty-Two dollars (\$10,262.00) in
7 B.U. 3400N, allotted under Saipan Local Law 18-24; One Thousand, Three Hundred and Thirty-
8 Five dollars (\$1,335.00) in B.U. 3700H, allotted under Saipan Local Law 19-27; and Twenty-
9 Eight Thousand, Seven Hundred and Sixty-Four dollars (\$28,764.00) in B.U. 3710D, allotted

1 under Saipan Local Law 20-03, for a combined total of Seventy-Five Thousand, Nine Hundred
2 and Fifty-Nine dollars (\$75,959.00).

3 **SECTION 2. RE-APPROPRIATIONS.**

4 Notwithstanding any provisions, statutes, laws or regulations to the contrary, the Saipan
5 and Northern Islands Legislative Delegation hereby re-appropriates the combined total in the
6 amount of Seventy-Five Thousand, Nine Hundred and Fifty-Nine dollars (\$75,959.00) from the
7 following Saipan Local Laws: Fourteen Thousand dollars (\$14,000.00) in B.U. 3389I, allotted
8 under Saipan Local Law 17-04; Sixteen Thousand, Three Hundred and Eleven dollars
9 (\$16,311.00) in B.U. 3374F, allotted under Saipan Local Law 17-09; Five Thousand, Two
10 Hundred and Eighty-Seven dollars (\$5,287.00) in B.U. 3399H, allotted under Saipan Local Law
11 18-07; Ten Thousand, Two Hundred and Sixty-Two dollars (\$10,262.00) in B.U. 3400N, allotted
12 under Saipan Local Law 18-24; One Thousand, Three Hundred and Thirty-Five dollars
13 (\$1,335.00) in B.U. 3700H, allotted under Saipan Local Law 19-27; and Twenty-Eight
14 Thousand, Seven Hundred and Sixty-Four dollars (\$28,764.00) in B.U. 3710D, allotted under
15 Saipan Local Law 20-03, to the following:

- 16 a) Fifty Thousand dollars (\$50,000.00) shall be allotted to pay for the Mayor
17 of Saipan’s outstanding debts incurred in Fiscal Year 2017 for the rental
18 of heavy equipment; and
- 19 b) Twenty-Five Thousand, Nine Hundred and Fifty-Nine dollars (\$25,959.00)
20 shall be allotted to the Mayor of Saipan’s operations for fiscal year 2018.

21 **SECTION 3. EXPENDITURE AUTHORITY.**

22 The expenditure authority for the funds under Section 2 of this Act shall be the Mayor of
23 Saipan.

24 **SECTION 4. REPROGRAMING.**

25 Notwithstanding any laws, provisions or regulations to the contrary, funds appropriated
26 under this Act shall not be reprogrammed for any other purpose.

1 **SECTION 5. REPORTING.**

2 The expenditure authority shall submit to the Chairperson of the Saipan and Northern
3 Islands Legislative Delegation a detail report showing the expenditure of the funds at the
4 completion of appropriations in Section 2 of this Act.

5 **SECTION 6. FUND DISTRIBUTION.**

6 Funds appropriated under Section 2 of this Act shall be distributed accordingly to the
7 intended purpose and or entity upon this Act becoming law.

8 **SECTION 7. FISCAL YEAR.**

9 The funds allocated under this Act shall be without fiscal year limitation(s).

10 **SECTION 8. SEVERABILITY.**

11 If any provision of this Act or the application of any such provision to any person or
12 circumstance should be held invalid by a court of competent jurisdiction, the remainder of this
13 Act or the application of its provisions to persons or circumstances other than those to which it
14 is held invalid shall not be affected thereby.


15 **SECTION 9. SAVINGS CLAUSE.**

16 This Act and any repealer contained herein shall not be construed as affecting any
17 existing right acquired under contract or acquired under statutes repealed or under any rule,
18 regulation or order adopted under the statutes. Repealers contained in this Act shall not affect
19 any proceeding instituted under or pursuant to prior law. The enactment of the Act shall not
20 have the effect of terminating, or in any way modifying, any liability, civil or criminal, which
21 shall already be in existence on the date this Act becomes effective.


1 **SECTION 10. EFFECTIVE DATE.**


