

Division of Administration

Crimes Against Persons

- Re-assessments on communications and internet connectivity
- Share and provide assistance with computer use and printing for those in need during daytime office hours
- Consider to purchase and network a highvolume multifunction printer for centralized printing, saving costs on purchasing multiple printers and consumables
- Working with Procurement office for the purchase of license plates

Challenges:

Division of Police

- Equip all police personnel with high-quality law enforcement gear and high caliber armor
- Outdated computers with obsolete operating systems to be compatible with software for daily operations
- Providing non-essential services with limited police manpower and the need to recall officers for overtime work
- Compliance with boat numbering of privately owned boats
- Launching Boating Safety boats on the East for emergency response
- Boating Safety trainings and certifications
- Repairs and labor of police fleet due to the lack of certified mechanics, non-availability of parts, and funding
- ◆ Considerable increase in volume of burglaries, theft, sexual assault, and domestic violence cases reported weekly
- Time restrictions on CIB daily operation
- Limited frontline and investigative manpower
- Manpower

Bureau of Motor Vehicles

- Resume issuance of REAL ID driver's license
- Order of license plate inventory

Division of Administration

- Vacancies: Local and federally funded positions including Police Cadets and state share match requirement
- No internet service connection at some DPS satellite offices affecting online communication and work efficiency
- Funding to equip all offices and report writing room with updated computers, software, and printers
- Funding for REAL ID
